Burn Permit Expires: Until Further Notice in May 2026

Burn day information: (530) 224-8777 call 9 am daily

This permit is valid only upon adherence to all of the specific conditions below:

1. A completed permit (this document) must be present with you during any burn operation.
2. Door-yard burning within the City of Shasta Lake is allowed on permissible burn days **ONLY**.
3. Burning days within the designated months are established by the Shasta County Air Quality Management District (AQMD). **You must call AQMD at (530) 224-8777 each day no earlier than 9 a.m.** to determine if burning is permitted on that day **(no burning allowed prior to 9 a.m.)**
4. You may not burn paper, cardboard, garbage, construction materials, animal or human waste, fabric or clothing, plastic or rubber items, roofing or tar materials or any other manmade products. Please note that the burning of any item which creates a public nuisance is prohibited.
5. You may only burn dry, cut vegetation from your yard.
6. All burning must be maintained in 4-foot maximum size piles at least 10 feet away from buildings and clear of any overheads.
7. No burn barrels or burning containers are allowed for door-yard burning.
8. An adult (18 years or older) with an effective water supply must be continuously present during burn operations.
- 9. All fires must be completely extinguished (dead-out-cold) by 5 p.m. – no exceptions.**
10. Violations of any of these rules may result in a citation or further legal action from the Fire Department or other agency.

FINAL STEP:

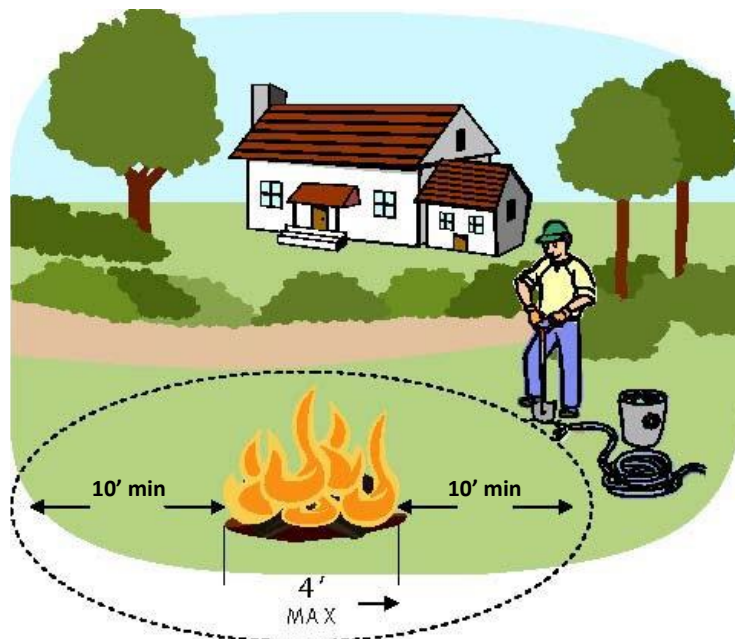
It is REQUIRED that you print a copy of this permit or save a copy on your mobile device for your records. As noted above in Item 1, you are required to have this permit with you during any burning operation. If you do not agree with all the burning conditions, as stipulated above, go no further – you will not be issued a permit and you may not conduct any burning. Receipt of this permit acknowledges that you have read and fully understand all of the burning conditions above. Once you enter the information above and have a printing device, you must print this permit. If you do not have access to a printing device, please contact Shasta Lake Fire District at (530) 275-7474 for assistance. **Again, you must print this permit and retain possession of this permit during your burning operation.**



Shasta Lake Fire Burning Regulations

The following are permit requirements for door-yard burning.

1. Dry vegetation may be burned on **PERMITTED BURN DAYS ONLY**.
2. Burn only on designated burn days.
3. No burn barrels allowed.
4. Maximum pile size 4-foot diameter.
5. Areas within 10 feet of the outer edge of the pile are maintained free and clear of all flammable material, vegetation, and any structures.
6. Adult (18 years or older) in attendance with a water supply and shovel until fire is dead out.
7. **All fires must be extinguished by 5:00 p.m.**
8. No burning shall be undertaken unless weather conditions (particularly wind) are such that burning can be considered safe.
9. Mechanically created piles must be inspected by Shasta County Air Quality Management District and the Shasta Lake Fire Protection District prior to burning.



Violations of Any Burning Permit Terms are a Violation of State Law
(Public Resources Code 4421, 4422, 4423, and 4425)
